Version 8.3.2 Release Memo

We are pleased to announce the release of STEPLogic Trace Version 8.3.2 using the STEPLogic 8 platform. STEPLogic Trace 8.3.2 release has 2 new features, and 8 bugs corrected. This release was part of an FMD NMVS compliance testing in 2025. These changes allow for proper communication with the new standards.

STEPLogic TRACE is a software application to manage and track the receipt, inventory and shipment of serialized products. It includes administrative support to configure and customize the solution for clients, and a user-friendly interface for running daily operations.

All product phases have been completed in accordance with the Körber Supply Chain LLC quality and system development life cycle policies and procedures.





General Application

Bugs Corrected

- 0046890: [App: Decommission Serials] Decommission Serials app is calling wrong MOCA command for sending adjustment to BY
- 0047608: [App: EPCIS Transactions] DEL_SHIP unpacking event is not adding timezone time difference like the other events in the message
- 0047530: [App: EPCIS Transactions] EPCIS transactions does not allow a resend of transactions if the XML already exists
- 0044954: [App: FMD Decommission] Arvato NMVS: The Alert ID should show immediately after scanning a serial that resulted in an Alert
- 0044944: [App: FMD Verification] The Request type to show FMD Terms and Conditions has changed since the initial version of Arvato NMVS
- 0044953: [Interface FMD] "alertId" attribute is not fetched correctly from the FMD Response XML and thus not populated in dml_epci_out_tran_det
- 0044970: [Interface FMD] Arvato NMVS: The response message from Arvato can contain a single quote. This needs to be removed from the content
- 0044938: [Interface NMVS] The Arvato NMVS interface has hardcoded the Arvato version in the SOAP header, causing the communication not to work

- 0047424: [App: FMD Verification] Changing App Icons for STEPLogic Trace FMD 8.3
- 0047344: [Archiving/Cleanup] Archiving process to move data from DML_CONTAINER_ATTR to DML A CONTAINER ATTR

Installation Notes

• EPCIS DEL_SHIP Unpack Events was showing a different time zone than other events in the same message. This change may affect downstream partners (more accurate dates than before).
